

PETITION FOR MEMBERS OF COUNTY COMMITTEE

PETITION MUST BE FILED WITH THE MUNICIPAL CLERK NO LATER THAN 4:00 PM ON THE 71st DAY PRIOR TO THE PRIMARY ELECTION (*N.J.S.A. 19:23-14*)

INSTRUCTIONS/GUIDELINES

1. The Candidate should fill in the blanks of this petition in its entirety **prior** to circulation.
2. **You can only be a candidate in the Election District in which you reside and are registered to vote in.**
3. **Please make sure you are getting signatures of qualified registered voters only. The signers must live within your election district. Voters affiliated with your political party and unaffiliated/undeclared voters are permitted to sign the petition. Signers belonging to a different political party and those residing in a different election district will be disqualified if challenged.**
4. The usage of either the official Democratic County slogan (Democratic Committee of Bergen County) or the official Republican County slogan (Bergen County Republican Endorsed Candidates) must be authorized by the chairperson of the County Party Organization. If the Chairperson does not authorize the use of their slogan, the Clerk's office will use the requested second-choice slogan on the ballot.
5. The candidate must sign the Oath of Allegiance before an officer authorized to take oaths in the State of New Jersey and the candidate must sign the Certificate of Acceptance (if multiple petition books are filed, this sheet only needs to be signed once and filed with the submitted petition).
6. Contact your Municipal Clerk for number of signatures required on your petition or visit www.bergenclerk.gov (*N.J.S.A. 19:23-8*).
7. Persons signing the petition must sign in their own handwriting and in the presence the circulator.
8. The person in whose presence the petition was signed must sign the Circulator Affidavit on page 5 of the petition and have their signature notarized by an officer authorized to take oaths in the State of New Jersey. The candidate may circulate their own petition and may be a signer of their own petition. Any circulator other than the candidate is eligible to sign the petition if the circulator is a qualified voter of the political subdivision for which the candidate stands for office, but a circulator may sign only one signature sheet endorsing a candidate. The circulator of the petition must be a registered voter of the State of New Jersey and be affiliated with the political party of the candidate for whom the petition is circulated (*N.J.S.A. 19:23-11*).
